## The regulatory environment

Companies that install profiling cookies are required to collect the consent of users (having the requirements under **art. 7 of the GDPR**) and provide the privacy policy, with which to make transparent, inter alia, the purposes for which the data are processed or transmitted to third parties. Where processing is based on consent, they must be able to prove that they have obtained consent and retain evidence.

This is a very expensive work for organizations, because for each non-technical cookie and for each script provided by third parties it is necessary to involve **different areas of the organization** (e.g. technical area, legal, marketing, etc.).

**COOKIE CHECK** allows you to comply with the European Data Protection Board (**EDPB**) **Consent Guidelines** and the **Data Protection Authority's instructions**.

## The solution

The adoption of **CORA COOKIE CHECK** allows you to:

- Identifying associated **Purposes and drafting** the related privacy policy and cookie policy;

- If the user provides partial consent, only allow the execution of scripts for which consents related to the purposes used have been collected, keeping the scripts (or portions of scripts) blocked using purposes for which you have not given your consent.

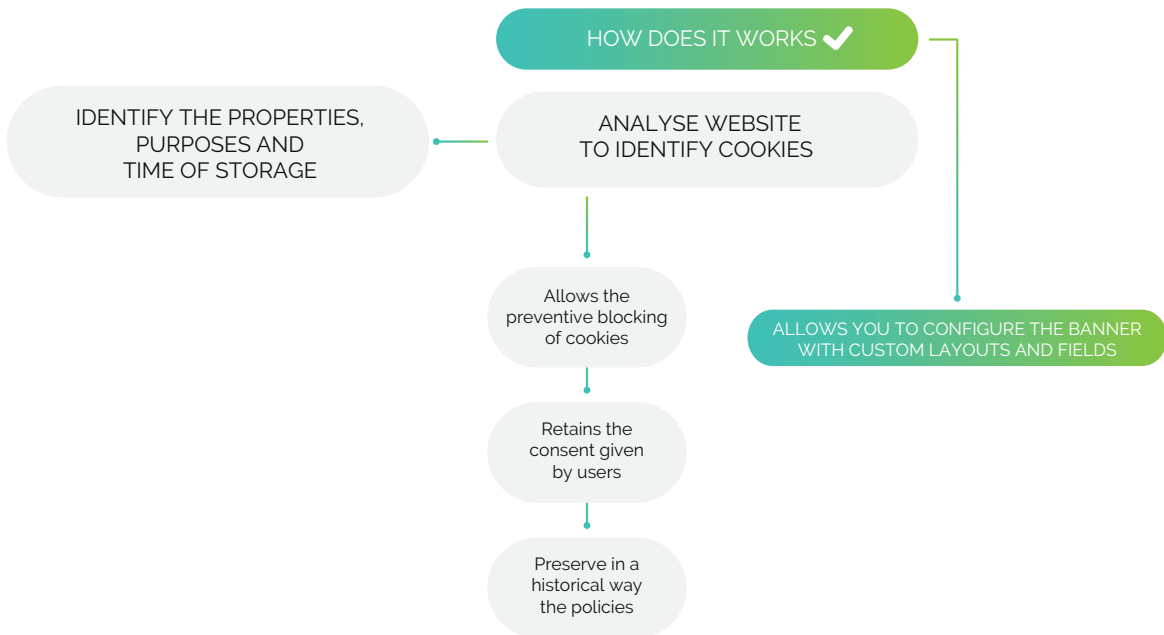
