Access management

The management of access and attendance to the various corporate headquarters, or to particular areas, is a subject currently not adequately manned, often managed through procedures not compliant with various rules and regulations, such as, for example, those on privacy and security.

Currently, in many cases, the reception provides visitors with paper forms in which it is possible to see personal data of other subjects present in the company, or request information without exposing or issuing an adequate information for the processing of personal data.

The regulatory environment

Is it legitimate to ask for the physical address? What about the phone number?

If the purpose is just registration at the entrance, probably this data is not necessary. However, if you intend to collect data for a future contact, or other purposes, such as to be able to alert those present in the company in case of emergency, this data could be essential and everything should be reported in a clear and concise.

According to the italian regulations on health and safety at work (d. lgs. 81/2008) it should then be possible at any time to know how many and which subjects are present in the building, and potentially locate them in case of emergency. The tracking is possible when the visitor is equipped with a badge that is registered at the time of transit.

The data must then be "stored in a form that allows the identification of data subjects for a period of time not exceeding the achievement of the purposes for which they are processed".

The user must also be given the right to request the cancellation of the data after the visit or in any case after the end of the purpose and in any case the possibility must be granted to the person to request the data held by the owner of the company.
