

EU Regulation 2016/679. Privacy and data protection.

The regulatory environment

On 14 April 2016, the **European Data Protection Regulation** was finally approved.

The new law completely repeals Directive 95/46/EC (Privacy) on the protection of personal data and has become directly applicable since 25 May 2018.

The regulation introduces a series of innovations in terms of obligations, rights and consequent risks, relevant for companies both from an economic point of view (penalties up to 4% of worldwide turnover) and reputational (possible consequences of an IT incident that endangers the integrity or confidentiality of the data).

Companies are therefore in a position to meet new needs:

- To make the activity carried out transparent and demonstrable (reduction of the sanction risks);
- To keep the organizational model constantly updated and adequate;
- To reduce the consequent organizational costs and impacts.

The solution

The module supports companies and agencies throughout the entire process of managing privacy obligations by automating and simplifying the necessary activities.

The solution is modular and configurable according to the characteristics of each individual organization.

"Governance" of the organisational model

The GDPR module provides a series of functions capable of ensuring the control of the implementation of the organizational model defined through:

- Activity dashboard
- Managing documents, versions and deadlines
- Continuous updating of the model
- Analytics and reporting

CORA GDPR can be integrated with the systems already present in the company (such as HR solutions, identity management, log collectors, ...) to derive organizational changes and risk analysis systems (as an alternative to the internal module). It can be used in "standalone" mode, but is part of a larger suite that can govern the entire corporate compliance model through a single synergistic system.

- Application Measures Safety

- Management of requests from interested parties
- Incident management
- Non-conformity and Corrective Actions
- Management of suppliers responsible for processing
